INDIVIDUAL COMMERCIAL SOUND AND TELEVISION BROADCASTING SERVICES' SHAREHOLDING STRUCTURE

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice in terms of section 4(3) (b) of the ICASA Act No. 13 Of 2000, read with Item 9 (d) of the Standard Terms and Conditions for Individual Broadcasting Services and the respective licence terms and conditions, of its intention to conduct an audit of Individual sound and television licensees' shareholding structure.
2. Individual sound and television licensees are requested to provide and/or confirm the following information in respect of their shareholding:
 - 2.1 the current shareholding;
 - 2.2 the percentage held by Historically Disadvantaged Individuals or groupings, if any; and
 - 2.3 the percentage held by youth, women and people with disabilities, if any.
3. Licensees are requested to provide proof of such shareholding in the form of CIPRO documentation and/or a sworn affidavit.

4. The information is requested from the licensees to allow the Authority to update its database of existing and operational licensees, which in turn would enable the Authority to plan its monitoring activities going forward.
5. Submissions are due by no later than **16h00** on: **30 August 2011**.
